

## Stella Della Valley 2009 Mail-In Registration Form

We strongly encourage everyone to register in advance for this year's Star Party. Pre-registration simplifies the check-in process, reduces the workload and wait at the registration desk, and allows the Star Party's organizers to more accurately assess the need for tents, chairs, and other facilities.

**Vendors and vendor assistants** are considered regular guests. The registration fee will be waived for the first vendor representative if door prizes valued at \$50 retail or more are donated. Additional vendor representatives must register as regular guests. Vendors are asked to make their intentions known in advance to avoid any confusion at the registration desk. Indoor tables are available for the Astronomical Flea Market at no charge (all are invited to setup, buy and sell).

### How to Register

Registrations are accepted by check or money order, **made payable to "BMAA"**, at the address below. Please include a printed copy of the 2009 Registration Form. **Note:** Stella Della Valley 2009, like any star party, is a "rain or shine" event. Registration fees are not refundable; our expenses are the same whether it's cloudy or clear! The event goes on even if the weather doesn't cooperate. On a positive note, it is worth mentioning that star parties are rarely completely clouded out. Stella Della Valley has always been scheduled for late September to early October due to the higher probability of good weather in Southeastern Pennsylvania. You can usually expect to get in a few hours of observing during a weekend even when the forecast doesn't seem particularly favorable.

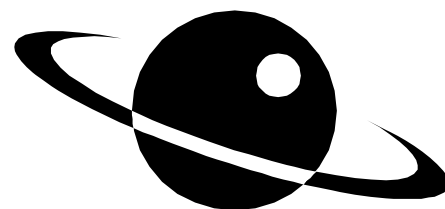
